*In accordance with CSC Memorandum Circular No. 14, s. 2013, and pursuant to CSC Resolution No. 1300979, the following policies on the qualification requirements for appointment to executive/managerial positions in the second level have been adopted, as stated thereon, to wit:*

1. **“CES and CSE eligibilities** are considered as sufficient for permanent appointment to division chief and executive/managerial positions...”
2. **“RA 1080 eligibles** shall be exempt from the master's degree requirement for division chief and executive/managerial positions...”

3. ***“Completion of the degrees of Bachelor of Laws and Doctor of Medicine form a CHED-recognized institution shall be considered appropriate education for appointment to division chief and executive/managerial...”***


