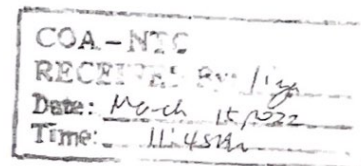
**CONTRACT FOR THE
PROVISION AND SUPPLY OF
JANITORIAL SERVICES
01 March 2022 to 31 December 2022**

THIS CONTRACT made on the FEB 28 2022 day of February 2022 between the **NATIONAL TELECOMMUNICATIONS COMMISSION – NATIONAL CAPITAL REGION** of the Philippines (hereinafter called “the Entity”) and **STARCOM MANPOWER AND ALLIED SERVICES, INC.** (hereinafter called “the Supplier”):

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PROVISION AND SUPPLY OF JANITORIAL SERVICES FOR NATIONAL TELECOMMUNICATIONS COMMISSION-NATIONAL CAPITAL REGION** from **January 1, 2022 to February 28, 2022** and has accepted a Bid for the Contract for the Provision and Supply of Janitorial Services in the amount of **SEVEN HUNDRED NINETY FOUR THOUSAND EIGHT HUNDRED THIRTY FIVE PESOS AND 69/100 only (Php 794,835.69)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Supplier/Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the Special Conditions of Contract;
 - (e) the BAC Resolution; and
 - (f) the Entity’s Notification of Award.




3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby undertakes to provide the entity with the provision and supply of security services in conformity with the provisions of the Contract.
4. The Entity hereby undertakes to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.


